



HIGUERON Projects, S.L. Smoke free policy

"Residences" building complex: 26 dwellings, 26 storerooms, 52 parking spaces and swimming pool in multi-family buildings.

The following policy has been adopted by HIGUERON Projects, S.L. to protect occupants and visitors from second hand smoke and smoke pollution, discourage smoking, minimize occupant exposure to secondhand smoke and reduce smoke pollution.

The only way to protect people from second- and thirdhand smoke is to implement a 100% smoke-free environment. Smoke-free environments to reduce cases of childhood asthma and other associated diseases later in life. In order to prevent the intrusion of cigarette smoke from outside, HIGUERON Projects takes measures to ensure that smoking is not allowed in the vicinity of building entrances, operable windows and building air intakes.

- Indoor smoking ban

Smoking of cigarettes and electronic cigarettes is prohibited indoors within the Project boundary.

- Outdoor smoking ban

Outdoor smoking is prohibited within 7.5 m of all entrances, windows, and air intakes. Signage indicating the no smoking ban is located on the main building entrances and on the building grounds walkways with a 30 m maximum distance between signs.

This Owner's Letter of Assurance is signed below and it is complemented with the smoking ban signs that describes the hazards of smoking and a schematic plan with the location of the signs.

R-A06. AIR QUALITY MONITORING. Part 3. Monitor Outdoor Air Quality.

An outdoor air quality monitoring system is installed within the project boundary.

The system takes measurements each minute of PM2.5, temperature and humidity.

It is owned and operated by the Home of Owners Association.

Environmental alarms are reflected on the home automation screens, and they also send the same message to mobile phones linked to the home automation so that the alarm can be reported remotely.

In each dwelling unit there is a display which shows the values of PM2,5, temperature and humidity. The system notifies the owner when the air quality overpass certain quality levels and recommends to keep the windows closed.

TEMPERATURE:

In the event that there is a difference of 8°C between the measurement of the external sensor and the sensor of the home automation screens of the rooms, an environmental alarm is issued with the following text: "Please keep the windows closed"

HUMIDITY:

In the event that the humidity rises to 65% as measured by the probe of the home automation screens of the rooms, an environmental alarm is issued with the following text: "Please keep the windows closed"

PPM:

In the event that the PPM 2.5 particles reach a threshold concentration of 16 $\mu g/m3$ as measured by the external probe, an environmental alarm is issued with the following text: "Please keep the windows closed"
